The Minutes of the meeting held on 30 June 2016 were approved as a correct record and signed by the Chairman.

171 16/00062/FUL – STAR LANE BRICK WORKS, STAR LANE, GREAT WAKERING

The Committee considered an application for the re-design of plots 4-13 (from approval 12/00252/FUL) to accommodate requirements for a pumping station.

Members considered that there were a number of items that required further clarification, which made it difficult for them to determine the application. They considered that the application should be deferred to allow time for the following issues to be addressed, in consultation with Ward Members:-

• Clarification around the location of affordable housing within the site;

- Clarification as to the reasons for the proposed location of the pumping station and timescale for this to be built in relation to the rest of the proposed development;
- Further work to be done to ensure that wheeled bins are located to the rear of properties, with proper access to collection points;
- Clarification around how the current shortfall in space standards compares
 to any shortfall in the previously approved application and an assessment
 made as to whether these can be improved; and
- Clarification as to whether the proposed garden sizes conform to the Council's minimum standards.

172 16/00323/FUL - 31 HIGH STREET, RAYLEIGH

(Note: Cllrs J C Burton and J E Newport each declared a non-pecuniary interest in this item by virtue of membership of Rayleigh Town Council.)

The Committee considered an application for the installation of a roller grille to enclose the entrance to the shop at 31 High Street, Rayleigh, which had been referred from the Weekly List by Cllr C M Stanley.

Resolved

- (1) The development hereby permitted shall be begun before the expiration of three years from the date of this permission.
- (2) No development shall commence, before details of the proposed materials to be used in the development have been submitted to and approved in writing by the Local Planning Authority. Such materials as may be agreed in writing by the Local Planning Authority, shall be those used in the development hereby permitted.
- (3) Prior to first use, the materials to be used in the construction of the roller grille hereby permitted shall be painted white in order to harmonize with the existing finish and treatment of the existing shopfront, blending more closely with other white-painted features on the building. (MD)
