REPORT FROM ASSISTANT DIRECTOR, LEGAL SERVICES

SUBJECT: VOLUNTARY ORGANISATION GRANTS 2016/17

1 DECISION BEING RECOMMENDED

- 1.1 To agree the recommendations made by the Member Advisory Group that met on 16 December 2015 to allocate grant funding of £35,000 to local voluntary organisations, as outlined in Appendix 1.
- 2 KEY DECISIONS DOCUMENT REFERENCE No: 13/15
- 3 REASON/S FOR RECOMMENDATION
- 3.1 To provide financial support to local voluntary organisations. Appendix 1 sets out the applications received and those recommended for funding by the Member Advisory Group along with the recommended amounts.

4 SALIENT INFORMATION

4.1 The criteria for considering applications are set out below:-

Organisations needed to show how they contribute to one or more of the Council's long term themes listed below:-

- o Place
- o Homes
- o Economic Growth

Applications will only be considered from groups meeting **all** of the following requirements:-

- Groups that are non-statutory organisations.
- Groups that are formally constituted.
- o Groups that operate in the not for profit sector.
- Groups that can clearly demonstrate their ability, through a grant award, to deliver benefit to the community within the grant year and to sustain their activities.
- Groups whose activities benefit residents of the Rochford District.
- Groups whose activities clearly contribute to, or support, Rochford District Council's long term themes.
- 4.2 An agreed scoring system was used to assess each application received, which assisted the Member Advisory Group in making its recommendations.
- 4.3 The Rayleigh, Rochford and District Association for Voluntary Service (RRAVS) will receive top sliced funding (of £15,000) from the overall pot. The remainder of the pot is allocated to small grants.

- 4.4 Service Level Agreements the intention is that a joint one year action plan with Essex County Council will be put in place to cover the funding provided to RRAVS.
- 4.5 In previous years the Rochford and Rayleigh Citizens Advice Bureau (CAB) was funded through this process. However, from April 2016 a new advice services contract will be awarded for three years. Therefore, CAB funding will no longer be part of this process.
- 4.6 Peppercorn rent is charged to the following organisations that run out of Council owned sites:
 - Old People's Welfare Committee for Rochford District (Day Centre Back Lane)
 - Rayleigh Age Concern (Todman Centre Rayleigh)
 - Hullbridge Senior Citizens Welfare Council (Windermere Avenue)
- 4.7 Information on current Discretionary Rate Relief totalling £12,415 is provided in Appendix 2.

5 ALTERNATIVE OPTIONS CONSIDERED

5.1 To reject the recommendations of the Member Advisory Group.

6 RISK IMPLICATIONS

- 6.1 The risks associated with the provision of grant funding to Third Sector organisations are;
 - (i) Funding is not used as stated by the applicant in their grant application.
 - (ii) Organisations misapply or make fraudulent use of the funding.
 - (iii) Stated service outputs and outcomes are not achieved;
 - (iv) Organisations in receipt of funding cease operating and the funding is put at risk.
 - (v) The activities of the grant recipient put the Council's reputation at risk. These risks are mitigated by;

Ensuring that the release of funding is subject to organisation's signing and agreeing to the conditions set out in the Council's grant agreement.

The Council monitoring the achievement of these outcomes through an annual monitoring process.

7 RESOURCE IMPLICATIONS

7.1 The 2015/16 budget for grants to voluntary sector organisations is £35,000. The Council is in the process of establishing the budget for the medium term and the overall budget allocation for small grants will be subject to the annual confirmation of the budget according to the Council's financial situation and budget setting process.

- 7.2 RRAVS was awarded £15,000.
- 7.3 Organisations applied for small grants of up to £1,500 per annum to deliver a range of projects or activities and the Member Advisory Group recommend the following levels of funding to applicants:

£20,000 revenue and capital funding to 19 organisations, ranging £476 to £1,500;

These recommendations are made subject to the conditions set out in paragraph 4.1

8 EQUALITY AND DIVERSITY IMPLICATIONS

8.1 Provision for groups to outline their equality and diversity procedure was made on the application form, which fed into the overall assessment. The awards of small grants will support specific vulnerable communities and ensure support is provided for smaller community projects. The distribution of grants using this process is likely to have a positive impact on these communities.

I confirm that the above recommendation does not depart from Council policy and that appropriate consideration has been given to any budgetary and legal implications.

The decision should be taken as a matter of urgency and not subject to call-in because under the Best Value Statutory Guidance local groups receiving grant aid should be notified of decisions relating to their funding at least three months before the start of the new financial year (by the end of December 2015.)
