EXECUTIVE DECISION BY PORTFOLIO HOLDER FOR PLANNING

SUBJECT: MEMORANDUM OF UNDERSTANDING – ESSEX COAST RECREATIONAL DISTURBANCE AVOIDANCE AND MITIGATION STRATEGY

1 DECISION MADE

- 1.1 Acknowledge the need for a Memorandum of Understanding (MoU) Essex Coast Recreational Avoidance and Mitigation Strategy (RAMS) as an effective means to discharge the Council's Duty to Co-operate responsibilities with other Essex Councils, and Natural England, in relation to this specific strategic and cross-boundary matter; and
- 1.2 Agree for the Assistant Director, Planning and Regeneration Services, to sign the MoU – Essex Coast RAMS (as previously circulated at Appendix A to the Key Report) on behalf of the Council and ensure that it is discharged at an operational level.

3 REASON FOR DECISION

3.1 The Council is required to comply with relevant legislation in discharging its responsibilities as a plan-maker such as the Conservation of Habitats and Species Regulations 2017. In signing the MoU, the Council will demonstrate that it is fulfilling the Duty to Co-operate in relation to the integrity of Natura 2000 sites, both in respect of neighbouring authorities and also in respect of Natural England, which is also a Duty to Co-operate body.

4 ALTERNATIVE OPTIONS CONSIDERED

4.1 The alternative option considered is that the Council could acknowledge the issues, but choose not to sign the MoU. However, this would not overcome the need for the Council to consider the potential impact of its emerging new Local Plan on Natura 2000 sites, as well as in combination with other authorities as a strategic, cross-boundary matter. It would also have an impact on the Council's ability to discharge its legal responsibilities under the Conservation of Habitat and Species Regulations 2017 and the Localism Act 2011 through failing to comply with the Duty to Co-operate.
