It was good to see so many members of the various councils at the launch of our parish plan. We all referred to the need to pursue the plan and it is now time to follow through on the draft action plan and turn it into a working document. For this to be a success we need your help.

As you are aware the actions are derived from the answers the residents and businesses gave to our questionnaires sent out in 2007.

There are five columns under the headings 'Main Responsibility', 'Others Involved', 'How funded', 'Deliverable Yes/No' and 'Timescale' to be completed for each action. These headings are our proposals and are not very different to action plans developed and being worked on by other parishes.

The preliminary input under each of the headings has been compiled based on our views and the replies we have already received from our discussions with Essex CC, Rochford DC, utility companies, educationalists etc. This is an ongoing process and we plan to issue an accurate working plan by mid year 2008. To meet this timing, we will need your input (plus of course input from HPC, ECC etc.).

We would ask you to look carefully at the draft of the Action Plan and come back to us with your comments so that we can amend it if necessary and move towards the working plan. This will be a live document and updated on a regular basis.

If we have suggested that RDC have responsibility for some actions and you disagree please let us know, including your reasons, and give us the correct responsible organisation.

If there are any aspects of the plan which can never be implemented, please advise which aspects together with an explanation?

If there are any aspects of the plan where action can be taken quickly, please let us know, including details, so that we can give an immediate response to the community?

We would welcome your overall comment on the quality of the plan (positive and negative) in order to feed back to the committee and volunteers. We would also welcome your thoughts on how we can move forward together in pursuit of implementing the plan. Is there anything that the committee of the Parish Plan Group can do to assist you in adoption and follow through of the plan?

We would be interested in your views regarding the introduction of a process for a two way information exchange on the status of any of the proposed actions in the plan.
