124 SCHEME OF DELEGATION

The Committee considered the report of the Corporate Director (Law, Planning & Administration) which invited Members to consider the Council's Scheme of Delegations with a view to improving it to meet the needs of the streamlined Committee system. At the request of Council, particular consideration needs to be given to the delegations surrounding the planning function.

Guidance from the Department of Transport, Local Government and the Regions states that it is essential that the Constitution contains a record of the allocation of responsibilities and delegation to Policy and other Committees or to officers in order to support transparency and accountability.

Appended to the report was a table fulfilling the requirements of Article 7 of the Constitution and which provided examples of how responsibility for delegations might be recorded. This had been used as the basis for the current delegations to Committee. Members noted that the model Constitution was intended to operate on a "by exception" basis.

Concern was expressed by Members that in planning it was often not possible to refer a matter to the Planning Services Committee or to Council. Members interface with residents and need to be able to demonstrate that their concerns can be addressed.

Members agreed that:-

- the report should include a broad band of delegations, concentrating on the checks and balances, for scrutiny by the Committee.
- examples from other Authorities of this type of delegation should be included in the Corporate Director's report on a draft scheme.
