

VARIOUS ROADS – ROCHFORD DISTRICT: UPDATE ON OUTSTANDING WAITING RESTRICTION REQUESTS INCLUDING THOSE WHICH ARE CURRENTLY BEING PROCESSED

1 SUMMARY

- 1.1 At the last meeting of the Transportation and Environmental Services Committee held on 30 January 2002, Members requested that they be informed of all requests for waiting restrictions.

2 INTRODUCTION

- 2.1 Each request for changes to existing or new waiting restrictions, has been investigated to ensure that it complies with the County Council's Parking Policy and can be fully justified.

3 PROPOSALS

- 3.1 The details of all accepted proposals are listed below.
- 3.2 Proposals marked with one asterisk (*) have been out to full consultation and no objections were received. The restrictions will be in force and the relevant signs and lines will be in place by 1 April 2002.
- 3.3 Proposals marked with two asterisks (**) are currently out to public consultation, the final date for objections will be 8 March 2002. Any objections that cannot be resolved will be put before the relevant committee as soon as possible, in order to meet the 1 April 2002 deadline.
