38 HACKNEY CARRIAGE DRIVER'S LICENCE, PRIVATE HIRE DRIVER'S LICENCE AND HACKNEY CARRIAGE VEHICLE LICENCE

The Committee considered the exempt report of the Head of Planning and Transportation relating to a driver falling outside the Council's licence conditions after receiving a Police caution for battery and failing to notify the Council of the Police caution within the required seven days.

The Transportation Manager advised the Committee that the driver's hackney carriage vehicle plate had, since publication of her report, been transferred to a relative.

The Committee, having given careful consideration to all the evidence and representations made, determined that the receipt of a Police caution and, furthermore, failing to report this to the Council within the required seven days, was a serious breach of the Council's licensing conditions.

The Committee was concerned that there was inconsistency in the information provided by the driver in relation to his health and the period during which he was taking medication. The Committee emphasised the need for Councillors to be satisfied that the driver was a fit and proper person to continue to hold hackney carriage and private hire driver's licences. The Committee accordingly deemed it appropriate to suspend the driver's hackney carriage and private hire driver's licences for a period of 3 months, subject to the Transportation Manager being provided with a satisfactory medical report. The driver's licences could be reinstated after this 3-month period, but only upon receipt of a satisfactory medical report.

Resolved

That the driver's hackney carriage and private hire driver's licences be suspended for a period of three months, subject to the Transportation Manager being provided with a satisfactory medical report. The licences to be reinstated after 3 months, only upon receipt of a satisfactory medical report. (HPT)
