130 LICENSING APPLICATION – LICENSING ACT 2003

Golden Lion, North Street, Rochford, SS4 1AS

The Sub-Committee considered an application for the review of a premises licence made under section 51 of the Licensing Act 2003 by Martin Howlett, Principal Environmental Health Officer at Rochford District Council. The application relates to a premises known as Golden Lion, North Street, Rochford, SS4 1AS. Members had before them the report of the Head of Environmental Services setting out the details of the application and the documentation and representations received from the applicant and various interested parties.

It was noted that, following further discussions that morning between the premises licence holder and the applicant, a series of additional conditions had been agreed between both parties to add to the existing premises licence. It was further noted that, as all parties were in agreement, the hearing would not take place and that the additional conditions agreed between the parties would be added to the premises licence.

Resolved

That the following conditions be added to the premises licence as additional, mandatory conditions:-

1. Section 177(A) (3) of the Licensing Act 2003 applies to this premises licence in relation to live and recorded music in the external areas of the premises.
2. A maximum of 4 live or recorded music performances can be held in any calendar year limited to Fridays, Saturdays, Sundays or Bank Holiday Mondays. Performances shall be for a maximum of 3 hours' duration during a 4-hour period from the start of the first period between the hours of 1200 – 2300 only. There will be a minimum of 12 days between performances. 2 of the performances must be associated with a beer festival.
3. A minimum of 10 days' written notice of each performance is to be given to the warden of Ormond House, Roche Close, Rochford, Environmental Health and the Licensing Department at Rochford District Council. Written notice will include the date, time, nature and noise control measures for each music performance.
4. There will be no live or recorded music in the courtyard at any other times. (HES)
