
RAYLEIGH TOWN CENTRE - OUTSTANDING ISSUES **(Min 94/02)**

1 SUMMARY

- 1.1 This report updates Members on the Rayleigh Town Centre outstanding issues discussed at the Environmental Services Committee on 12 March 2002 .

2 BACKGROUND

- 2.1 The last meeting of the Rayleigh Town Centre Forum was in September 2001: outstanding issues of concern for Rayleigh Town Centre were subsequently discussed at the Environmental Services Committee meeting in March 2002. At that meeting, Members requested that the Environment Overview and Scrutiny Committee consider a further update report three months hence.
- 2.2 An updated list of the issues and actions taken to date is listed in Appendix One attached to this report.
- 2.3 In addition, Members also requested that consideration be given to the frequency of updates in the future. Accordingly it is suggested that a further update be provided in six months time.

3 RECOMMENDATION

That Members consider the details of the update on the outstanding Rayleigh Town Centre issues and determine whether there is a need for a further update to a future meeting of the Environment Overview & Scrutiny Committee. (HPS)

RAYLEIGH TOWN CENTRE UPDATE

<p>1. Reinstatement Quality Control Process Paving standards throughout the town are poor; frequently due to lack of grouting. Highways are aware of the areas outside the Mobile Phone shop and the Library. <p>2. General condition of Town Centre is looking poor - particularly street furniture Highways agreed that the Town Council should undertake the painting of seats, bins, bollards, railings and lamp posts up to the lights. <p>3. Bollard opposite the Superdrug store at the junction of the High Street and Eastwood Road This had been hit again following repair, demonstrating the difficulty caused by that kerblane. <p>mm in the direction of Eastwood Road and also towards the Church end of the High Street. The Chamber of Trade reported that it is currently not safe to follow the Highway Code and go around the existing 'spot' and that moving the kerbline would be one solution. They are disappointed that local transport operators are often not consulted on important Highway issues.</p>	
<p>4. Junction of Church Street and Websters Way. Area Manager to report back to Members on this before the next meeting, together with the outcome of a traffic light study at the junction of Websters Way/Hockley Road/High Street.</p> <p>During further debate on items related to this issue, Members raised a concern relating to traffic flow round and through Rayleigh Town Centre and requested that the Lollypop Ladies be re-educated to allow traffic to flow, whilst balancing the need for pedestrians to cross the road safely.</p> <p>The issue of improved crossing facilities at the top of Crown Hill were mooted. However, the Area Highways Manager was of the opinion that the current zebra crossing was the best solution that could be achieved in this area.</p>	<p>Report awaited from County Highways</p> <p>Complete - reported to Environmental Services Committee 9/4/02. <p>5. Taxi Shelter – Boots Lagoon The Rayleigh Times had incorrectly reported that the Town Council had been asked to provide a taxi shelter in the Boots Lagoon. Await outcome of Traffic Regulation Order before matter is progressed. Town Council will have the opportunity to formally register objections.</p>	<p>The provision of shelters to be considered after a decision on revisions to the Traffic Regulation Order</p>
<p>6. CCTV Rayleigh Town Council reported that CCTV is only of real benefit if regularly monitored. 14 or 15 cameras would be the ideal number. In order to use as evidence in support of crimes, the Police have advised that the lenses need to be more focused.</p> <p>The Town Council confirmed that the correct procedure would be followed regarding trees which are currently obscuring views and the issue of siting cameras on listed buildings. They hoped soon to finalise their plans with the Police for the positioning of cameras.</p>	
<p>7. Love Lane Car Park – Exit Survey County Highways to report on progress.</p>	<p>To be carried out when resources allow. Insufficient in-house resource; consultant to be briefed</p>
<p>8. Flowers The Town Council reported that the contractors have been advised of the poor condition of flowers this year, particularly in flower baskets. Watering has recommenced on a daily basis, although insufficient funds may mean this regularity cannot continue.</p>	<p>Rayleigh Town Council</p>
<p>9. Update on Traffic Regulation Order It was noted that the advertisement relating to the Traffic Regulation Order would be published on or before 5 October, with a three week public consultation period. Whilst the matter was in the public domain, Essex County Council's Legal Department would be preparing the documents for formal consultation which would occur immediately afterwards. Any objections to the Traffic Regulation Order could be reported back to the District Council's Transportation & Environmental Services Committee on 28 November 2001.</p>	<p>TRO being processed - Implemented</p>

<p>10. Paving at Millennium Clock The Town Council reported that they were continuing to chase the Eastern Electricity Board for resolution of this matter.</p>	<p>Rayleigh Town Council</p>

Fly-posting Fly-posting still not being removed promptly – monitoring officers are still not dealing with this as quickly as Members would like – there is also a need to remove the attachments (cable ties, sticky tape, etc)</p>	<p>Monitoring Officers are dealing with removal when this is possible. However, they are unable to remove posters on private property when stuck on glass windows, etc, as there are Health and safety implications. Overall there is a resource issue around this task as the monitoring officers have more duties than they are able to cover in their working hours.</p>
<p>14. Brooklands Members requested details of ownership of a piece of neglected land on the embankment outside Brooklands. The pond at this site is also in need of cleaning.</p>	<p>Rochford District Council/County Highways</p> <p>The embankment outside the site has been cleared of vegetation by ECC. RDC has cleaned the embankment of litter on a number of occasions.</p> <p>The pond was partially cleared in 2001, and is being cleaned and cleared of weeds in February 2002. <p>24. Cleaning under waste bins – update It was noted that no response had been received from the District Council's Property Maintenance and Highways Manager. The Working Group agreed that he should be invited to meet with the Chamber of Trade to walk the Town Centre to be shown the problem areas. The Working Group considered the matter concerned environmental standards which apparently were not being met. If this was the case, it was requested that a report be brought to the Transportation and Environmental Services Committee.</p>	<p>Rochford District Council A meeting was held with representatives of the Chamber of Trade in 2001. The areas under the bins are being cleaned of collected rubbish. However, as pointed out at that meeting, some of the staining is due to rusting of the bins which need redecoration. EPA standards are being met in Rayleigh High Street and appropriate monitoring indicates that the standard is being met on 99% of the inspections.</p>
<p>25. General Condition of Town Centre Essex County Council advised that they allocated a fifth of the Town Centre budget for furniture to be painted on a year on year basis. The Town Council advised there was still a question over responsibility for the painting works and Essex County Council advised they would speak further with their Legal Department and endeavour to clarify matters in due course.</p>	<p>Town Council/County Highways</p>

<p>26. Dead Trees outside Sansoms and Iceland</p> <p>It was noted that the County Arboriculturist was of the opinion that the death of the tree could possibly have been caused by a gas leak. <p>27. Mechanical Sweeper – Town Centre</p> <p>Members had before them the Cleansing Schedule for the mechanical sweeper in Rayleigh High Street. The Group were of the opinion that it was hard to believe the mechanical sweeper was performing up to standard, indeed it was mooted that the schedule included roads, which some District Council Members believed had been removed at the Contract specification stage.</p> <p>It was noted that the Town Councillors present did not have a copy of the Schedule. The Working Group requested that the Council's Monitoring Officers look into the situation of whether the mechanical sweeper was indeed being used at the times stated on the Schedule as they believed the time periods used were not achievable.</p>	<p>Rochford District Council</p> <p>Schedules of sweeper operation have been provided to the Chamber of Trade.</p> <p>The list of roads being swept has been amended in line with Members' requests.</p> <p>Monitoring of the sweeper has been ongoing and records of activity are kept.</p>
<p>28. Skateboard Nuisance</p> <p>It was noted that this matter was being reported to the next meeting of the Council's Community Services Committee on 2 October.</p>	<p>Rochford District Council now followed statutory process to implement a Bylaw in liaison with DTLR.</p>
<p>29. Flowers</p> <p>The Working Group were advised that the Town Council had recently advertised a three year contract for hanging baskets in the Town Centre. It was noted that the report in the Rayleigh Times had misinformed people that the hanging baskets were solely the work of the Town Council and it was requested that the Town Council write to Rayleigh Times in order for an article to be placed thanking the sponsors for their help in this year's flower display.</p>	<p>Rayleigh Town Council</p>

Clean Up areas to the rear of Websters Way Members requested that a report be brought back to the Working Group on the District Council's responsibilities for ensuring areas to the rear of shops were clean and clear of rubbish.
