GRANTS TO OUTSIDE ORGANISATIONS

1 SUMMARY

1.1 This report sets out the applications to be considered for financial assistance in 2007/08. Appendix 1 sets out the applications received and those recommended for funding.

2 CRITERIA

2.1 The criteria for considering applications is set out below:-

Organisations needed to show how they contribute to one or more of the Council's corporate aims listed below:-

- To work towards a safer and more caring community
- To promote a green and sustainable environment
- To encourage a thriving local economy
- To improve the quality of life for people in the District
- To maintain and enhance the local heritage and culture

In addition, the Council wish to give priority to organisations that provide a local service either solely or mainly for the following priority groups:-

Older people.

People with disabilities or who are disadvantaged. Young people.

Applications will only be considered from groups meeting all of the following requirements:-

- Groups that are non-statutory organisations.
- Groups that are formally constituted.
- Groups that operate in the 'not for profit' sector.
- Groups that can clearly demonstrate their ability, through a grant award, to deliver benefit to the community within the grant year and to sustain their activities.
- Groups whose activities benefit residents of Rochford.
- Groups whose activities clearly contribute to or support Rochford District Council's Corporate aims.

3 SERVICE LEVEL AGREEMENTS

- 3.1 This Committee agreed in January 2007, when reviewing the criteria, that Service Level Agreements (SLA) would be developed with organisations receiving significant levels of funding. It is recommended that the following organisations have a SLA if the proposed level of funding is agreed.
 - Citizens Advice Bureau
 - Rochford Sports Council
 - Foot Prints Community Group
 - Old Peoples Welfare Committee for Rochford
 - Rochford, Rayleigh Association of Voluntary Service
 - Hockley and Hawkwell Old Peoples Welfare Committee
 - Rayleigh Age Concern

4 ORGANISATIONS NOT MEETING THE CRITERIA

4.1 There are seven organisations that have requested funding but do not meet the Council's criteria based on their applications and proposed use of the grant. These are set out in Appendix 2. One of the organisations listed is Mayday Mobile. In 2006/07, Mayday Mobile were awarded a grant of £1,220. They have not been recommended for funding in 2007/08 because the Council already provides accommodation to the organisation and also works with the Wyvern Community Transport scheme to provide community transport to all sections of the community.

5 **RESOURCE IMPLICATIONS**

5.1 Applications for funding can be met within the agreed budget. The total of the recommended applications is £28,350 plus £79,000 for the Citizens Advice Bureau.

6 PARISH IMPLICATIONS
