Stakeholders need to be involved at the next stage, including Parish representatives (Rawreth Parish Council, Hullbridge Parish Council, Rettendon Parish Council); appropriate Rochford and Chelmsford Members; County Highways; County Urban Design; Environment Agency; and landowners.
