# 99 APPOINTMENT OF THE EXECUTIVE, COMMITTEES AND SUB-COMMITTEES 2015/16

Council considered the report of the Chief Executive on the discharge of business during the 2015/16 Municipal Year.

The Leader of the Council advised, in response to a Member query relating to the particular scope of portfolios, that animal welfare lies within the community portfolio and that the issues associated with the clearing up of Michelins Farm lie within the environment portfolio, although partnership working with external agencies would be required.

### Resolved

- (1) That the appointees to the Executive (including associated portfolios) be noted, as detailed in appendix 2 to these minutes.
- (2) That the Chief Officer Appointments Committee be re-constituted on the basis of the arrangement in the last Municipal Year to conclude its work on appointing to the Chief Officer posts resulting from the leadership and organisational redesign 2014.
- (3) That Committees and a Sub-Committee be constituted as shown in the appendix to the report.
- (4) That Members be appointed to serve on Committees and a Sub-Committee for the 2015/16 Municipal Year, as set out in appendix 3 to these Minutes.

A Motion moved by Cllr T G Cutmore and seconded by Cllr M J Steptoe that a minor amendment be made to Council policy around chairmanship of the Review Committee such that any Member of the Council not a member of the majority group may be nominated for the position of Chairman of Review Committee was carried on a show of hands. In response to a Member question relating to the Constitutional status of such a change in policy, officers advised that this was a minor amendment to policy specific to the Annual Council meeting, rather than a change.

(Note: Cllrs Mrs D Hoy, M Hoy, Mrs C M Mason and J R F Mason wished it to be noted that they had voted against this decision and Cllr M Hoy also withdrew his nomination as Chairman of the Review Committee.)

A further Motion moved by Cllr T G Cutmore and seconded by Cllr M J Steptoe that Cllr J H Gibson be appointed as Chairman of the Review Committee was carried on a show of hands. During debate of the Motion a Member questioned why the Review Committee did not appoint its Chairman. It was emphasised that the Constitution made no specific reference to the appointment of Chairmen of Committees, however Committee Chairmen had always been appointed at Annual Council. Officers advised, in response to a further question raised by a Member relating to page 4.40 of the Constitution, that no recent amendments had been made to this page.

(Note: Cllrs C I Black, J C Burton, J Hayter, N J Hookway, Mrs D Hoy, M Hoy, Mrs C M Mason, J R F Mason and R A Oatham wished it to be noted that they had voted against this decision.)

A further Motion moved by Cllr T G Cutmore and seconded by Cllr I H Ward and that Chairman of the Local Development Framework Sub-Committee be appointed at the first meeting of the Sub-Committee was carried on a show of hands.

- (5) That any Member of the Council who is not a member of the majority group can be nominated for the position of Chairman of the Review Committee.
