201 10/00234/OUT AND 13/00552/REM – LAND WEST OF OAK ROAD AND NORTH OF HALL ROAD, ROCHFORD

The Committee considered the report of the Director relating to proposed revision to the affordable housing tenure for the development so far approved in respect of applications 10/00234/OUT and 13/00552/REM – land west of Oak Road and west of Hall Road, Rochford.

While concern was expressed by some Members that local residents would not be able to afford to enter into a shared ownership arrangement and that the likelihood was therefore that shared ownership affordable housing would be taken up by people living outside the area, others acknowledged that those on the Rochford housing register could benefit from the rented social housing that would be available as part of this development. It was emphasised that the Council could not determine the social landlord; this was determined by the developer.

Resolved

That the proposed amendment to the affordable housing tenure in the affordable housing scheme approved for the first phase (as defined in the Section 106 agreement dated 1 July 2013) permitted by reserved matters approval 13/00552/REM pursuant to outline planning permission 10/00234/OUT to 70% social rented and 30% intermediate affordable housing be agreed, pursuant to paragraph 2.1 of Schedule 1 of the Section 106 agreement.
