The Proper Officer reported that, pursuant to Council Procedure Rule 12, the following Motion had been received from Councillors P F A Webster, T G Cutmore, P A Capon, Mrs T J Capon, R G S Choppen, K A Gibbs, T E Goodwin, J E Grey, Mrs S A Harper, C A Hungate, Mrs L Hungate, T Livings, Mrs M D McCarthy, G A Mockford, J M Pullen, P K Savill, C G Seagers, S P Smith, D G Stansby, Mrs M J Webster and Mrs B J Wilkins:-

"The Government has refused to consult the British people on proposals for a European Union Constitution for the United Kingdom.

Rochford District Council therefore believes it is in the interest of its residents and their children to participate in a nation-wide ballot on this important issue to be sponsored by a national daily newspaper. The vote will be held on Thursday 12 June 2003. In the absence of a national referendum, this at least will give people the opportunity to express a view on the implications of such a Constitution for Britain."

In presenting the Motion, Cllr P F A Webster referred to the lack of opportunity being offered to the people of Britain to take part in a national referendum on a European Union Constitution for the United Kingdom. The British people should have the right to decide for themselves how their country should be governed.

In support of the Motion, some Members believed that the proposed amendments to the European Constitution posed a threat to British sovereignty and independence and would result in Britain no longer being a constitutional state with its own legal status. Arguing against the Motion, however, some Members felt that it was inappropriate to make recommendations to residents on how to vote on national or international issues.
