OUTSIDE BODY REVIEW (Minute 259/00)

1 SUMMARY

1.1 Members are invited to consider whether the number of Outside Bodies, on which this Authority serves, should be reviewed. Appointments to Outside Bodies is a discretionary function.

2 INTRODUCTION

- 2.1 Members will recall, at meetings of Council and Finance and General Purposes last year, appointments were made to Outside Bodies. These appointments were made for the Municipal years 2000/2001 and 2001/2002 given that there would be no District Council elections in 2001. Attached at Appendix 1 is a list of the Outside Bodies.
- 2.2 Historically appointments to Outside Bodies have been made on a year on year basis, at the request of a body, without question as to whether representation on the Body would enhance or improve the service offered by this Authority to Council Tax payers.
- 2.3 In drafting the original report last year, work was undertaken by officers to ascertain the purpose of Outside Bodies and the timing of their meetings, with a view to providing Members with a more balanced view of the possible commitment made by Members on appointment.
- 2.4 At Council on 25 July, all Outside Bodies were appointed to, with the exception of those requiring subscription. At the time of drafting this report there are 57 Outside Bodies to which this Authority nominates 1 or more Councillors.
- 2.5 It is suggested that Members may wish to review the number of Outside Bodies, on which this Authority is represented. Though not exhaustive, reasons include: -
 - There could be a conflict of interest between the Membership of an Outside Body and the Council, particularly where a Member is acting as a trustee, as the first duty of the Member would be to the Trust.
 - With the abolition of attendance allowances, Members will only be able to claim travel and subsistence from the Authority (in cases where these are not paid by the Outside Body). At the present time, the only appointments attracting an attendance allowance are

those relating to the Association of Essex Authorities (AEA) and the Local Government Association (LGA)

- With meetings of Outside Bodies falling at various times of day there can be a clash with District Council Meetings
- Given the Modernising Agenda, it is anticipated that Members will spend more time working in partnership with other organisations, listening and working with the Community etc.

3 SUGGESTED REVIEW CRITERIA

- 3.1 The following are possible Criteria which could be used to identify whether an Outside Body should have a representative from this Authority serving on it: -
 - Has the Council given strong financial support to the Outside Body?
 - Does the Body either provide a direct service for the Council Tax Payers or are the objectives of the Body closely aligned with the Council's direct interests?
 - Is it essential for the Council to be involved in the policy making or management of the Outside Body?
 - Can the body be considered to be a part of the Local Government process?
- 3.2 It is suggested that as part of any review, the mechanisms for reporting back into the Council, by Members, should also be examined.

4 **RESOURCE IMPLICATIONS**

4.1 A reduction in the number of Outside Bodies could potentially produce Budget savings. All claims are currently paid from existing budget.

5 **RECOMMENDATION**

It is proposed that the Committee **RESOLVES**

- (1) whether a review of Outside bodies should be undertaken
- (2) the criteria to be used should (1) above be agreed

(3) That a report be brought back to a future meeting detailing the findings of the review (HAMS)
