DOWNHALL ROAD RAYLEIGH PROPOSED INSTALLATION OF PEDESTRIAN CROSSING

1 SUMMARY

1.1 The purpose of this report is to ask Members to consider the objections received to a proposal to introduce a zebra crossing on the above road.

2 INTRODUCTION

- 2.1 Downhall Road is a Class III road joining the main A129 London Road, Rayleigh. It is a busy route carrying a high volume of traffic into Rayleigh. It is well used by pedestrians and, in particular, schoolchildren on the "walking bus" on their way to school, commuters to the station and local shoppers. A crossing point is being considered between the junction of the London Road and the entrance to The Travellers Joy.
- 2.2 Although an initial request was for a crossing point in the vicinity of Sheridan Close, visibility and proximity to the bend made the site unsuitable. In addition, traffic speeds are in excess of 35mph. Safety Audit recommendation is not to install zebra crossings where speeds are in excess of 35 mph.

3 PROPOSAL

3.1 To install a zebra crossing in the location, as shown in Appendix A. This proposal was advertised on site and in the local press for the required length of time. Three letters of objection were received and their comments are outlined below.

Visitors could be asked to park within the owners' driveways.

Mrs Longbridge 6 Downhall Road	Drivers are travelling too fast	See comments above
	Reversing off the drive will be difficult	As in any reversing movement care must be taken and the introduction of the crossing should make no difference

- 3.2 In conclusion, it is difficult to judge exactly what effect this improvement will have on the highway network. Similar objections were raised when Essex County Council installed crossings in Grove Road and Clarence Road. Both sites demonstrated congestion, side turnings in close proximity and complications due to the nearby bus stop and the school. The crossings were installed and have been successful additions to pedestrian facilities in the area with no adverse effects on the travelling public.
- 3.3 As with any new installation it will take a little time for users to become familiar with the operation of the facility and the adjustments that have to be made approaching the site. However, this will provide a much needed crossing point that will be welcomed by many pedestrians in the area.
