# 136 ARTICLE 4 DIRECTIONS REMOVING PERMITTED DEVELOPMENT RIGHTS (TO ERECT MEANS OF ENCLOSURE AND TO SITE CARAVANS) ON LAND NORTH OF BULL LANE, RAYLEIGH

The Committee considered the report of the Head of Planning Services regarding the apprehended breach of planning control on land to the north of Bull Lane, Rayleigh. It was noted that this land was sold by auction in 2001 and plots had been advertised locally. Prospective purchasers of the land had repeatedly called in requesting information regarding the planning status of the site and saying they had been led to believe the permission for residential purposes would be a formality.

In agreeing the Officers recommendation, Members noted that a Planning Officer of this Authority lived nearby and that his family had ownership interests and farmed the adjoining land.

#### Resolved

That the Corporate Director (Law Planning & Administration) be authorised to serve Article 4(1) and 4(2) directions under the General Permitted Development Order 1995 (as amended) on the land in question to secure the remedying of the apprehended breach of planning control now reported.
