The total expenditure for this programme was £66,051.

3 LOCALLY DETERMINED PROGRAMME 2003-2006

- 3.1 Local views on distribution of the funding have been sought by consulting with County Councillors, District Councillors, Parish Councils and Rayleigh Town Council.
- 3.2 Members were invited to prioritise Locally Determined Schemes using the general headings listed below. In addition, Members and Parishes were asked to consult with each other regarding which local schemes they wished to support and to make those schemes known to Essex County Council through the Parish and Town Council replies.

- 3.3 The replies have been analysed in accordance with the method outlined and agreed in Item 15 of the Transportation and Environmental Services Committee report of 28 November 2001. The resulting list of local priorities is:-
 - 1 Residential Zones
 - 2 Footway Imrovements
 - 3 Layout Improvements
 - 4 Street Lighting Improvements
 - 5 Pedestrian Facilities
 - 6 General Improvements
 - 7 Traffic Regulation Orders
 - 8 Environmental Improvements
 - 9 Special Maintenance
 - 10 Cycling Facilities

- 3.4 As in previous years it is likely that the total value of the locally determined scheme list will exceed the allocation of funding.
- 3.5 A proposed programme has been drawn up to reflect these priorities. Categories in the lower half of the list are still regarded as important and schemes within those categories should still be progressed where possible with the finance available. It is expected that with a 3 year rolling programme now being considered there will be more scope to bring forward these schemes into the programme as nominated schemes are completed. In addition, if a scheme is delayed, then it would be beneficial to have additional schemes in the programme ready to commence. A particular example to demonstrate this has been the delay caused by the protracted land negotiations that were part of the Stambridge Road Post Office footway scheme.
- 3.6 Schemes/Measures proposed by consultees, including Parishes, are shown on the following lists.
- 3.7 The level of funding for the Locally Determined Budget this financial year is £80,000. The programme shown in Section 5 is estimated to total this figure. Schemes forming the rolling programme will be done if selected schemes do not progress or schemes are completed for less than the budgeted figure. Section 4 shows the rolling programme of schemes.

4.2 PRAM CROSSINGS

During 2000 a survey was carried out in all Parishes to identify where pram crossings were required. These sites form the basis of the rolling programme to be looked at each year until all sites have been completed. The full list of sites is held at Churchill House.

4.3 KILL YOUR SPEED POSTERS

Between October 2003 and March 2003 the Rochford Team arranged for "before, during and after speeds" to be taken as signs were erected throughout the district. Details of the findings are reported in Appendix A.

<u>APPENDIX A</u>

REPORT TO MEMBERS ON THE EFFECT OF CHANGES MADE TO THE "KILL YOUR SPEED POSTER" CAMPAIGN IN ROCHFORD DISTRICT

CAMPAIGN PURPOSE

To raise awareness for motorists to reduce traffic speed in urban areas within Rochford District

Funding

Typically £7,500 per annum from the Locally Determined Budget

Background

Kill your speed posters are sited in roads where concern has been raised regarding the speed at which drivers are travelling. The roads are added to a list forming a rolling programme of sites where Kill Your Speed Posters are erected and are maintained in place for approximately 4 weeks.

Questions have been raised regarding whether the posters have any real affect in raising driver's awareness. This would be demonstrated by evidence of reduced speeds in the road and would justify the costs involved in maintaining the campaign. Comment was also raised regarding the impact effect of the posters as they were often sited some distance away from each other. At the Environment Committee 9th April 2002 an item in the "Presentation of the Locally Determined Programme 2002/2003" advised that a survey would be carried out to gather information to enable a decision to be made over the future of this campaign

The programme has been reviewed and the following amendments made:

- Location of the posters were focused on individual parishes to assist in effective management of the workforce and give better value in reducing time and costs on site.
- The number of posters at each location has been increased to 8 and are sited on consecutive lamp columns or posts to increase the visual impact to motorists.
- Speed checks were taken before during and after erection of the posters to measure the effectiveness of the programme.

The amended programme came into effect in October 2002 and ran through until March 2003.

Conclusion

Pre October 2002 review:

- No recorded evidence shows that the posters actually reduced speeds
- Costs in removal and resiting the posters fluctuated due to the programmed sites being spread out around the District.

Item 10

- 3 July 2003

Post October 2002 review:

- Increased efficiency when moving the signs between locations
- A reduction in speeds of between 2-5mph in some locations was recorded
- Positive feedback was received from Essex County Council, Rochford District Council officers and telephone calls to ECC commenting on the visual impact of the signs to motorists.

Recommendation: It is recommended that Members agree to continue the programme.
