REVIEW OF OUTSTANDING ENFORCEMENT CASES

1 SUMMARY

This report provides Members with information on a review of the outstanding enforcement cases and provides details of cases that have been closed as a result of the review.

2 BACKGROUND

- 2.1 Following the Review Committee's review of the operation of the Planning Enforcement Service (Minute 104/(2)/07), it was agreed that an annual review be carried out of the enforcement caseload with the aim of ensuring that outstanding cases were closed, where appropriate, as quickly as possible.
- 2.2 The current caseload stands at 408 open cases, including 13 category A, 31 category B and 364 category C cases. Members will recall that category A cases comprise the most serious breaches of planning control and that most attention is therefore focused on their resolution.
- 2.3 The annual review has now been completed. In total 228 cases have been reviewed and, as a result, it has been possible to close a total of 59.
- 2.4 The category breakdown for the review cases was: 12 category A, 14 category B and 202 category C. Of the 59 cases closed in the review, the breakdown was: 4 category A, 2 category B and 53 category C. The details of the cases that have been closed can be found in appendix 1 to this report.

3 CONCLUSION

- 3.1 An annual review of the enforcement caseload has been accepted as good practice and in this instance a total of 59 cases have been closed.
- 3.2 The next review will be completed in early 2009 and subsequently reported to Members.

4 ENVIRONMENTAL IMPLICATIONS

4.1 The investigation and resolution of breaches of planning control is a priority for the Council. In many instances, breaches can have a significant negative impact on the environment of the District and the amenity of residents.

5 **RECOMMENDATION**

5.1 It is proposed that the Committee **RESOLVES**

That, subject to comments from Members, the results of the annual review of enforcement caseload be noted.
