However, the arrangements for dealing with unauthorised Gypsy and Travellers sites are complicated by the requirements to comply with the provisions of the Human Rights Act and by a recent change in national planning policy. A review of the East of England Plan is underway to take account of the requirements of national legislation that an assessment be carried out of the need for the provision of pitches for Gypsy and Traveller caravans in the East of England districts. An issues and options paper was published by the East of England Regional Assembly in May 2007 and the Council is waiting for the outcome from that consultation to determine the appropriate course of action for dealing with this site. | S Scrutton Rochford District Council 01702 318100 |
