BRAMERTON ROAD, HOCKLEY: PROPOSED WAITING RESTRICTION/ROSSLYN CLOSE – CUL-DE-SAC: PROPOSED REVOCATION OF EXISTING WAITING RESTRICTION

1 SUMMARY

1.1 The purpose of this report is for Members to consider the responses received following the formal consultation with residents of the above roads on the proposals set out in the report.

2 INTRODUCTION

- 2.1 Bramerton Road is an estate road flanked on both sides by residential properties and situated a short distance from shopping facilities in Spa Road, and within walking distance of Hockley town centre and railway station. Concerns have been raised by local residents regarding inconsiderate parking that occurs on the south-west side of the road which is currently un-restricted, reducing the available carriageway to one lane, obstructing access to adjacent properties, and creating unreasonable noise in the early hours by commuters when vacating their vehicles.
- 2.2 The south-west side of the road had already been recommended for a waiting restriction (11am 12noon Mon Fri) by the Highway Authority at the previous Hockley review of waiting restrictions in 2000, but due to an administration error at that time was overlooked in the final draft, and the restriction could not be introduced.
- 2.3 Rosslyn Close cul de sac is situated on the west side of Rosslyn Close and forms a small group of seven properties. Although some distance from Hockley town centre and shops, it is within walking distance of the railway station.
- 2.4 All seven householders would like the existing waiting restriction (11am 12noon Mon Fri) revoked in the interests of improving their quality of life, as some of the residents have more vehicles than they have available parking space on their properties, and the restriction disrupts the free-flow of residents parking.

3 PROPOSAL

3.1 Full details of the proposals are included in Appendices A and B to this report. Following the usual informal and formal consultation process, plus a letter drop to householders, letters of both support and objection to the proposal for Bramerton Road were received.

- All of the residents in the Rosslyn Close, cul de sac support the proposal by way of a petition.
- 3.2 Bramerton Road has been monitored by staff from the area office on an ad hoc basis over the previous eighteen months, in an effort to ascertain the extent of the reported parking problems. During that time few problems were witnessed at the northern end of the road, but it is acknowledged that considerable on-street parking does occur at the southern end, being closer to the parade of shops in Spa Road, and Hockley town centre.
- 3.3 The road is almost one-half mile from the railway station. The County Council has published a parking policy document which offers guidelines to officers dealing with proposals for the introduction of waiting restrictions, and although there appears to be insufficient reason to justify the introduction of such a measure, the majority of local residents who responded to the consultation process are in support of the proposal.

4 OBJECTIONS

4.1 Seven letters of objection to the proposal for Bramerton Road were received, and there were thirteen letters of support. Six residents did not respond to the mail-drop, and are therefore considered to have no strong convictions on the matter.

5 OPTIONS

Bramerton Road

- 5.1 Overrule the objections and proceed with making the Order for Bramerton Road.
- 5.2 Withdraw the proposal.

Rosslyn Close

- 5.3 Proceed with revoking the current waiting restriction on the cul-de-sac section of Rosslyn Close.
- 5.4 Withdraw the proposal.

6 CRIME AND DISORDER IMPLICATIONS

6.1 Whilst not objecting, The Chief Constable has taken a position of 'non support' with respect to the proposals set out in appendices A & B.

7 ENVIRONMENTAL IMPLICATIONS

7.1 None in respect of the proposed recommendation.

8 RESOURCE IMPLICATIONS

8.1 Funding for the proposals have been provided from the County Council's locally determined budget for Rochford District for 2003/2004.

9 LEGAL IMPLICATIONS

9.1 A Traffic Regulation Order will have to be made for the waiting restriction in Bramerton Road, should the proposal be approved.

10 PARISH IMPLICATIONS

- 10.1 Hockley Parish Council has been consulted and has made no comment.
- 10.2 Rochford District Council has been consulted and supports the proposal for Bramerton Road, but does not support the proposal for Rosslyn Close culde–sac.
- 10.3 Both County and District Council Members have been consulted and support the proposals.

11 RECOMMENDATION

- 11.1 It is proposed that the Committee **RESOLVES**
 - (1) That the waiting restriction be introduced in Bramerton Road, Hockley.
 - (2) That the existing Order covering the cul-de-sac section of Rosslyn Close, Hockley be revoked. (County Highways)
