488 MOTIONS ON NOTICE

(1) From Councillors C I Black, R A Oatham, C J Lumley and Mrs J Lumley

The Proper Officer reported on a motion received from the above named Councillors pursuant to Council Procedure Rule 12. The motion was moved by Councillor R A Oatham and seconded by Councillor C J Lumley.

Councillor Oatham confirmed that the objective of the motion was to draw attention to an imbalance of housing development across the District and associated infrastructure pressures.

During debate Council noted that:-

- The Rochford District Local Plan (Adopted 1988) and the Rochford District Local Plan First Review (Adopted 1995) had been carried out in accordance with statutory requirements and had involved extensive public consultation/consideration of representations. The Plan had been subject to a public local inquiry.
- The Authority was required to determine all planning applications based on their individual merits and in accordance with material planning considerations.
- If housing allocations associated with the 1988 Local Plan were factored into the figures set out in the report, Rayleigh figures would stay the same but provision associated with the rest of the District would increase to approximately 40 hectares.
- The Local Plan was currently under review and subject to public consultation. It was important that the Council did not fetter its ability to make future decisions based on material issues and predictions of sustainability.

An amendment to the motion was moved by Councillor P F A Webster and seconded by Councillor T G Cutmore.

During debate of the amendment it was observed that the Council did not know what future housing land allocation demands might be pending the publication of new Regional Planning Guidance. Reference was made to the role the Government had in influencing planning policy/decisions. Reference was also made to some of the clear constraints to development within the

District, such as areas of flood plain and green belt. It was also observed that some developments had been passed on appeal.

The amendment was agreed on a show of hands and it was:-

Resolved

- (1) That this Council notes that:-
 - For the period 1998-2011, large scale housing development has not been evenly balanced across the District.
 - As shown below, more than half has been in Western Rayleigh and Rawreth (the three Wards of Grange, Sweyne Park and Downhall and Rawreth).
- (2) That this Council re-affirms that all future land allocations, throughout the District, will be judged solely on their planning merits. (HPS)

491 IMPLEMENTING ELECTRONIC GOVERNMENT

Council considered the report of the Head of Administrative and Member Services on approval of the Implementing Electronic Government 3 (IEG3) statement for submission to Government.

During debate it was noted that the IEG capital grants were fixed amounts and that funding had been provided for partnership pump priming. The Office of the Deputy Prime Minister had not yet announced whether capital grants would be available in 2004/05 following submission of a satisfactory IEG3 Statement , but there had been some informal indication that this may be the case.

Council observed that it was pleasing that the previous IEG Statements had been successful in obtaining the capital grants and endorsed the observation of a Member that synergy could be associated with partnership working. Reference was made to recent software demonstrations which had provided Members with a detailed insight into the potential of current applications. Potential could also be associated with development of the working relationship with Vivista, the Council's IT contractor.

Officers were thanked for their work in formulating the bid submission and it was:-
