I write in reference to the pavement permission application.

The Council as the Local Planning Authority is in the process of determining a planning application, ref 21/00054/FUL decision due on the 30th of March 2021. This application seeks permission for a *'change of use from A1 (Retail) to Sui Generis Use as a Micro Pub'*. Whilst this planning application is independent of the licence application process, the comments to the licence application are without prejudice nor do they predetermine the outcome of the planning application.

The outside seating given the size of the pavement appears not to allow for sufficient space to accommodate outside seating without causing an obstruction on the pavement. There does not appear to be sufficient room to accommodate the proposed seating and other pavement users thereby posing a safety risk. Therefore, the recommendation is to await the outcome of the planning application thereafter revisit the application for the pavement licence.

Good afternoon Mr Greener

Th Chief Officer of Police remains concerned regarding the above application; in particular that it appears the sole reason given for the council's refusal of the application is one of none compliance with dimensions set out within the Business and Planning Act 2020 and that an appeal of those grounds for refusal is now under consideration. The Business and Planning Act 2020 does not appear to have any such dimensions but, in terms of obstruction refers to the need to take into account the needs of disabled persons <u>and</u> recommended distances set out within guidance.

The Chief Officer of Police again restates his earlier objection to the application and <u>in particular</u> his observations regarding crime and disorder and public nuisance. You will of course be aware that Section 17 of the Crime and Disorder Act 1998 states that all relevant authorities – which includes district, town and parish councils – have a duty to consider the impact of all their functions and decisions on crime and disorder in their local area.

The placement of chairs outside a bar encourages persons to remain outside as their level of intoxication rises, invariably increasing the noise and profanities of customers. If permission was granted there would be a need for a condition to be attached for the tables and chairs to be removed from the footway etc. at the end of each day at the time any authorisation lapsed.

BUSINESS AND PLANNING ACT 2020 – PAVEMENT PREMISSION APPLICATION 16 GOLDEN CROSS PARADE, ROCHFORD, ESSEX. SS4 1UB

I am writing in reference to your recent application for pavement permission at the above address under the Business and Planning Act 2020.

The Licensing team have consulted with statutory partners such as Essex Highways, Essex Police, Rochford District Council Environmental Health and Planning Department.

The original application was refused on the basis of failure to comply with our Standard conditions and the National Conditions due to the limited space on the public highway.

Following my letter dated 9th February 2021 outlining the grounds for refusal, as requested the group have re-assessed your application based on the revised number of 4 chairs and 2 small tables.

Representations

Rochford District Council Licensing Team received two (2) formal representations from our partners in relation to your application and two (2) representations from local residents. The details of the representations are listed below:

Essex Police

The Chief Officer of Police remains concerned regarding the above application; in particular that it appears the sole reason given for the council's refusal of the application is one of non compliance with dimensions set out within the Business and Planning Act 2020 and that an appeal of those grounds for refusal is now under consideration. The Business and Planning Act 2020 does not appear to have any such dimensions but, in

The Chief Officer of Police again restates his earlier objection to the application and in particular his observations regarding crime and disorder and public nuisance. You will of course be aware that Section 17 of the Crime and Disorder Act 1998 states that all relevant authorities – which includes district, town and parish councils – have a duty to consider the impact of all their functions and decisions on crime and disorder in their local area.

The previous submission on behalf of the Chief Officer of Police included:

Furthermore, the proposed hours of operation are very likely to lead to public nuisance and potential disorder given the area is one of residential premises with flats immediately above and to each side of the premises in question.

Essex Police is currently considering the concurrent application under the Licensing Act 2003 for the premises to sell alcohol and provide live and regulated entertainment and has concerns that the premises is going to be primarily operated as a bar.

The placing outside of tables and chairs outside a bar has proven in the past to create noise and disorder problems and this would be another reason that Essex Police would consider the application as unsuitable.

The placement of chairs outside a bar encourages persons to remain outside as their level of intoxication rises, invariably increasing the noise and profanities of customers.

The objection based on crime and disorder and public nuisance would apply to the provision of any outdoor seating provided by the applicant given the premises residential location and intended use as a bar

Rochford District Council Planning Department

The Council as the Local Planning Authority is in the process of determining a planning application, ref 21/00054/FUL decision due on the 30th of March 2021. This application seeks permission for a 'change of use from A1 (Retail) to Sui Generis Use as a Micro Pub'. Whilst this planning application is independent of the licence application process, the comments to the licence application are without prejudice nor do they predetermine the outcome of the planning application.

The outside seating given the size of the pavement appears not to allow for sufficient space to accommodate outside seating without causing an obstruction on the pavement. There does not appear to be sufficient room to accommodate the proposed seating and other pavement users thereby posing a safety risk. Therefore, the recommendation is to await the outcome of the planning application thereafter revisit the application for the pavement licence.

Representations from the Residents

Group Meeting to discuss your application

After careful consideration and looking at your application and the representations from residents and our partners we have refused (under the BUSINESS AND PLANNING ACT 2020) your application on the following grounds:

• The group felt that the business should run as a bar for at least 6 months (if the Alcohol Licence was granted) and demonstrate to the residents and partners that the venue can be run safety and reassure residents that the outside seating area would not create additional noise or concerns.

The group felt that the venue should re-apply under the Pavement Permission legislation (Highways Act 1980) once they have completed a 'bedding in period' of running the venue in accordance with the Licensing objectives.

Can I appeal the decision

Under the Business and Planning Act, there is no statutory appeal process for these decisions, however, Rochford District Council will be permitting appeals to the Licensing and Appeals Committee.

There is no timescale set within the legislation for the period of time between receiving the appeal request and the date of a hearing, however would look to present the application to the panel at the most appropriate time.
