However, it should be noted that the recently published Housing Green Paper proposes that a proportion of the 3 million homes proposed to be built by 2020 should be built in the north, but of course, the overall numbers for the growth areas in the south are also proposed for increase. However, the arrangements for dealing with unauthorised Gypsy and Travellers sites are complicated by the requirements to comply with the provisions of the Human Rights Act and by a recent change in national planning policy, and the Council must carefully consider its position before determining the appropriate course of action to follow to deal with this matter.
