133 MINUTES

The Minutes of the meeting held on 12 April 2023 were noted and signed by the Chairman.

EXCLUSION OF THE PRESS AND PUBLIC

Resolved

That the press and public be excluded from the meeting for the remaining business on the grounds that exempt information as defined in Paragraph 3 of Part 1 of Schedule 12A of the Local Government Act 1972 would be disclosed.

134 BUSINESS RATES WRITE OFF

The Executive considered the report of Interim Director of Resources seeking agreement to write off a sum in respect of business rates.

A typographical error in paragraph 1.1 of the report was noted; it should state 1 May 2020.

In response to a Member question as to why the debt went back to May 2020, officers advised that the company occupied the premises from May 2020 and at that time received Small Business Rate Relief with a 100% deduction. In August 2022 the Valuation Office Agency split the rating assessment into two parts; legally they were no longer entitled to Small Business Rates Relief on either part and therefore had to be billed for the full business rate amount

going back to 1 May 2020, which resulted in these charges which were now subject to the write off.

In response to a Member question in relation to the share of the write off that should be funded by RDC officers advised that the cost was as set out in report, i.e., £6,680.00; the other preceptors would bear the rest of the cost. RDC had a write off provision which covered its portion of the debt.

Cllr J R F Mason moved a Motion, seconded by Cllr J E Newport, that the recommendation set out in the report be approved.

Resolved

That the sum of £16,699.00 in respect of business rates is written off. (IDR)

(This was agreed unanimously)

135 BUSINESS RATES WRITE OFF

The Executive considered the report of the Interim Director of Resources seeking agreement to write of a sum in respect to business rates.

Cllr J R F Mason moved a Motion, seconded by Cllr J E Newport, that the recommendation set out in the report be approved.

Resolved

That the sum of £21,961.29.00 in respect of business rates is written off. (IDR)
