In January 2007 Stansted Transit took on operation of the service, operating the same timetable, with minor alterations to certain journeys. The County Council has no jurisdiction over its operation. Due to the poor performance of the service Stansted Transit reduced the frequency in July to provide basically a 90-minute frequency. The major concern from users was that the first and last journeys operated only between Chelmsford and Rayleigh. When Essex County Council asked Stansted Transit the cost of extending these journeys through to Southend, the cost per passenger journey exceeded the County's support criteria and, therefore, they were unable to increase the service.
