76 ANNOUNCEMENTS FROM THE CHAIRMAN

Cllr Mrs J R Gooding confirmed that her chosen charity for 2021/22 was East Essex Hackspace, a local charity she had supported since its beginning. East Essex Hackspace was a hub which aimed to benefit the local community, enhancing emotional wellbeing through socialising and positive engagement. To date East Essex Hackspace had initiated a project making thousands of 3D printed face shields for key workers across the District during the pandemic using their fully equipped workshop facilities to benefit our community. They have also reconditioned used laptops and iPads donated by the public for the benefit of young people without the technology to access online learning. Hackspace also work alongside another charity called Remap, which is a charity which creates bespoke items to help disabled people live more independent lives. Hackspace also make the hub space available for use by Remap. These two charities working together will continue to provide a needed service for our local community as well as further afield.

Members vote for each nominee as the name is called out and those with the higher number of votes are appointed to the outside bodies.
