628 BREACH OF PLANNING CONTROL ON LAND NORTH OF RICKING HALL, NEW HALL ROAD, HOCKLEY

631 BREACH OF PLANNING CONTROL AT LAND OPPOSITE WITHERDENS FARM, CHELMSFORD ROAD, RAWRETH

The Committee considered the report of the Head of Planning Services on breaches of planning control, namely the siting of caravans, constructions of hard standings, out buildings, etc. on land opposite Whetherdens Farm, A130 Chelmsford Road, Rawreth.

Item 2 - 02/00813/FUL - 50 to 54 West Street, Rochford

Proposal - Demolition and Replacement of 50 – 52 West Street with 3 No. Dwellings; Conversion of 54 West Street and Attached Outbuildings to 2 No. Dwellings; together with erection of 3 No. Dwellings to the Rear.

Mindful of officers recommendation for approval, Members considered nevertheless that the application should be refused and it was:-

Resolved

That the application be refused for the following reason:-

In the opinion of the Local Planning Authority, the applicants have failed to demonstrate that Nos.50-52 West Street are beyond repair and have not fully explored the possibility of restoring the building. In the absence of compelling evidence that the building is structurally and/or economically beyond repair, the building's demolition and the site's redevelopment is considered contrary to Policies UC5 and UC7 of the Rochford District Local Plan First Review and the guidance of Planning Policy Guidance Note 15: Planning and the Historic Environment.

(Note: Councillor Mrs H L A Glynn wished it to be recorded that she had voted against the above decision. Cllrs D F Flack, J Thomass and Mrs M J Webster wished it to be recorded that they had voted in favour).

Resolved

That authority be delegated to the Head of Planning Services, in conjunction with specialist advisers, to issue Urgent Works Notices in respect of 50 - 54 West Street, Rochford (HPS)

Item 3 - 02/00812/CON - 50 to 54 West Street, Rochford

Proposal - Application for Conservation Area Consent for the complete demolition of 50 and 52 West Street together with the partial demolition of 54 West Street.

Resolved

That the application be refused for the same reason for refusal of Application No. 02/00813/FUL. (HPS)

Item 4 – 02/00786/COU – Land at Pelhams Farm, South of Hall Road, West of Cherry Orchard Way, Rochford

Proposal - Change of Use of Agricultural Land to Football and Cricket Pitch Use (Re-submission following 02/00296/COU)

That the application be approved subject to the conditions set out in the Schedule and the additional conditions in the addendum. (HPS)

Item 5 – 02/00617/FUL – Land opposite Rayleigh Cemetery, Hockley Road, Rayleigh

Proposal – Erect Two Storey Building comprising 76 Bed Elderly Residential Care Home, Layout Access and Parking.

Mindful of officers recommendation for refusal, Members considered nevertheless that the application should be deferred and it was:-

That the application be deferred pending the production of an adequate survey of reptiles on the site and to allow the other reasons for refusal to be addressed. (HPS)
