
GRANTS TO OUTSIDE ORGANISATIONS

1 SUMMARY

- 1.1 This report sets out the applications to be considered for financial assistance in 2008/09. Appendix 1 sets out the applications received and those recommended for funding. In 2007/08 a sub-committee was established to assess the grants applications and it is proposed that the same committee is re-established to oversee the process for this financial year.

2 CRITERIA

- 2.1 The criteria for considering applications are set out below:-

Organisations needed to show how they contribute to one or more of the Council's Corporate Aims listed below:-

- To provide an excellent cost effective frontline service for all our customers
- To work towards a safer and more caring community
- To promote a green and sustainable environment
- To encourage a thriving local economy
- To improve the quality of life for people in the District
- To maintain and enhance the local heritage and culture

In addition, the Council wish to give priority to organisations that provide a local service either solely or mainly for the following priority groups:-

- Older people.
- People with disabilities or who are disadvantaged.
- Young people.

What groups will be considered for funding?

Applications will only be considered from groups meeting all of the following requirements:-

- Groups that are non-statutory organisations.
- Groups that are formally constituted.
- Groups that operate in the not for profit sector.
- Groups that can clearly demonstrate their ability, through a grant award, to deliver benefit to the community within the grant year and to sustain their activities.
- Groups whose activities benefit residents of Rochford.

- Groups whose activities clearly contribute to or support Rochford District Council's Corporate aims

3 SERVICE LEVEL AGREEMENTS

3.1 The Committee agreed in January 2007 that, when reviewing the criteria, Service Level Agreements (SLA) would be developed with organisations receiving significant levels of funding. It is recommended that the following organisations have a SLA for the year 2008/09 if the proposed level of funding is agreed:-

- The Old Peoples Welfare Committee for Rochford
- The Hockley and Hawkwell Old Peoples Welfare Committee
- Rayleigh Age Concern

3.2 It is also recommended that the Citizens Advice Bureau and Rochford Sports Council as 'top sliced' organisations have three year SLA's developed

4.1 Applications for funding can be met within the agreed budget.

5.1 Organisations in all the Parishes will considered for funding.

6 RECOMMENDATION

6.1 It is proposed that the Board **RESOLVES** to re-establish the Grants to outside Organisations Sub-Committee with the same membership as 2007/08 (Cllrs T G Cutmore (Chairman), K J Gordon, Mrs H L A Glynn, R A Oatham and Mrs M J Webster) and to delegate authority to that Sub-Committee to determine the grants to be made for 2008/09.
