PETITION FOR SKATEBOARDING FACILITY –GREAT WAKERING

1 SUMMARY

1.1 This report advises Members of the receipt of a petition signed by 195 people, requesting support for a skateboarding facility in Great Wakering.

2 INTRODUCTION

- 2.1 A number of young people in Great Wakering have set out to gain support for the provision of a skateboarding facility in Great Wakering, by collection of signatures on a petition.
- 2.2 A copy of the petition is attached as Appendix A

3 EXISTING FACILITIES IN GREAT WAKERING

- 3.1 Members may be aware of the Council's expenditure in recent years to provide additional facilities in Great Wakering. The list includes:
 - The new senior playspace built in 2001/02 in Morrins Close.
 - The new infant playspace in Glebe Close.
 - Refurbishment of the playspace in the High Street, including additional funding from the Cory Environmental Trust, gained through installation of disability compliant equipment

3.2 **Consultation with Great Wakering Parish Council**

3.2.1 When Great Wakering High Street playspace was identified as a priority in 2003/04, officers wrote to the Parish Council on 21 January 2004asking whether the rolling programme should address the issue of skateboarding, and identifying that this would require additional financial support from the Parish (up to £15,000), and public consultation on the location of such facilities. A negative response was received from the Parish Clerk verbally. The Parish Council was unable to provide financial support to a level that would finance a skateboarding park.

4 CRIME AND DISORDER IMPLICATIONS

4.1 Skateboarding facilities do contribute to the provision for older youths in a positive manner, although location of such facilities is critical in relation to those who are likely to be near neighbours.

5 **RESOURCE IMPLICATIONS**

- 5.1 The annual capital provision for playspaces is used for refurbishment of playspaces, as and when they become due for renewal. Playspaces are chosen on the basis of risk assessment. At present there is no budget provision for additional playspace provision such as skateboarding in Great Wakering.
- 5.2 If Members wished to support additional skateboarding provision, appropriate sites would first need to be identified and costings obtained. A bid could then be made for funds during the budget process.

6 **RECOMMENDATION**

6.1 It is proposed that the Committee **RESOLVES**

To note the petition and consider skateboarding in terms of Council priorities for the future
