Introduction

There are two parts to this document – section 1 lists the schemes to be delivered in the current financial year and section 2 provides details of the schemes to be considered for the 2010/11 programme.

It is anticipated that, unless otherwise stated, the schemes listed in section 1 will be completed by the end of this financial year. The rolling programme of Vehicle Activated Signs has been underway since the beginning of June. Item 1.9 shows progress on maintenance schemes (re-surfacing and re-construction) throughout the District.
