TAXI LICENSING

1 SUMMARY

- 4 March 2004

1.1 Members to consider the recommendations of the Taxi Licensing Sub-Committee which met on 20 February 2004 in a consultative capacity with representatives of the taxi trade.

2 INTRODUCTION

- 2.1 The Council, by virtue of a regulatory requirement with respect to the licensing of Hackney Carriage and private hire vehicles and drivers, meets with trade representatives twice a year to discuss charges for services provided (around February each year) and any proposed taxi tariff change (around June/July each year). At the meeting on 20 February Members noted the background to the formulation of proposals, a key aspect being that charges to the trade should provide a cost neutral service to Council Tax payers. It was also noted that the charges would come into effect on 1 April 2004 and that, since reported publication, the Criminal Records Bureau had advised that its charge for Criminal Records Disclosures would be set at £33.00.
- 2.2 Members also considered a number of guidance indicators, which might help them consider any future request for increases to the taxi tariff. Officers were directed to provide year on year comparisons for:-
 - RPIX the General Retail Prices Index, excluding Mortgage interest payments
 - CPI the Government's inflation target figure
 - The percentage increase associated with pensions.
 - The percentage increase in Council Tax
 - The percentage increase associated with wages
 - The percentage increase with the insurance cover required for 'hire and reward'

3 RECOMMENDATION

- 3.1 It is proposed that the Committee **RESOLVES**
 - (1) That, there being no strong objections from the taxi trade to the proposed charges and subject to the charge for Criminal Record Disclosures being set at £33.00, the 2004/05 charges for Hackney
