# **Returning Officers proposals**

Polling district RCJ (192 electors) and RCK (329 electors) comprise part of Ashingdon ward of Ashingdon parish and at present they both use Ashingdon United Free Church hall as their polling station. It is proposed to combine RCJ and RCK and have the electors continue to use the church hall.

Polling districts RCL (981 electors) and RCM (159 electors) comprise the whole of Canewdon parish, which is unwarded. At present both RCL and RCM use Canewdon village hall as their polling station. It is proposed to combine these polling districts and have the electors continue to use the village hall.

Paglesham parish is unwarded and in a very rural area. It is at present divided between polling districts RCN (84 electors) and RCO (123 electors). The Mission Hall in the village has previously been used for RCO. The Disability Discrimination Act 2006 requires that, so far as is practicable, every polling station should be accessible for electors who are disabled. The Mission Hall is unacceptable for disabled voters as it is inaccessible for wheelchair users or electors with mobility problems. Therefore, it is proposed to combine polling districts RCN and RCO (giving a combined electorate of 207) and have all electors voting in the Congregational Church hall which has no access problems.

# **Returning Officers proposals**

The parking arrangements at the parish hall in Little Wakering Road are unsatisfactory as the site is situated on a sharp bend. However the area is rural and the only alternative site is Barling Magna Primary School on the opposite side of the road and this is now used for polling district RCF. At the May elections this year polling station staff received comments from voters about the proximity of the two stations and questioned the need for separate sites. However the school site is not deemed large enough to contain a split station.

For many years the polling station for RCF has been the Castle Inn, Little Wakering Road, however prior to the May 2007 elections it became clear that this venue would be unavailable as it had closed for business. An alternative site at Barling Magna Primary School was used at the May 2007 elections and it is proposed to continue with this use for future elections.

It is proposed to combine RCE and RCF polling districts and use Barling Magna Primary School as the polling station.
