# HULLBRIDGE VILLAGE CENTRE IMPROVEMENT SCHEME

# 1 SUMMARY

- 1.1. This report advises Members of the work carried out by the Hullbridge Village Working Group in suggesting improvement works in the Village.
- 1.2. The report seeks approval to the scheme and authorisation for the design brief to be released to the Essex County Council Design Consultant.

# 2 PROGRESS

- 2.1. The Group will have met on nine occasions, had one site visit and held an open meeting for traders. In addition, examples of street furniture and paving materials have been on display at the Parish Council offices in order that members of the public may give their views on the most appropriate design.
- 2.2. A scheme has now been agreed in principle. Plans and artist impressions are currently on display in the Members Rooms at Rayleigh and Rochford.
- 2.3. A design brief has also been agreed, a copy of which is also on display in the Members Rooms at Rayleigh and Rochford.
- 2.4. A meeting of the Group will be held on 3 July prior to this Committee. Decisions will be made with regard to the design of paving materials and street furniture. These decisions will be reported verbally on the evening.
- 2.5. Forms have been made available to the public in Hullbridge through various outlets. An analysis of the responses received is shown at Appendix 1 of this report.
- 2.6. From the comments received the proposed improvements would meet the high priority wishes of the public.

# **3 CO-OPERATION OF LOCAL TRADERS**

- 3.1. Owing to the street layout in Hullbridge, the majority of the area which would normally be thought of as footway is private forecourts which are in the ownership of the various shopowners.
- 3.2. The proposed improvements would only have an impact if all of the shop frontages were included within the scheme.

- 3.3. From early contact with shop owners, it became clear that the substantial majority would not be prepared to pay for works to be carried out to their frontages.
- 3.4. In view of the above, the Working Group devised a design for the refurbishment whereby the public footway would be paved, but the shop frontage areas could be resurfaced using a low cost material which would, nevertheless, improve the visual aspect of the area as a whole. By doing this, it is suggested that the work to the shop frontages be carried out at Council expense.
- 3.5. The shop owners were then consulted as to whether or not they would allow access to their frontages for this work to be undertaken and also whether they would consider sponsoring items of street furniture.
- 3.6. At the time of drafting this report, a response is still awaited from 3 of the shop owners. An anlalysis of the responses to date is shown at Appendix 2 to this report.

# 4 ENVIRONMENTAL IMPLICATIONS

4.1. The scheme will enhance the visual aspect of the main shopping parade and allow easier access for the disabled.

# 5 PARISH IMPLICATIONS

5.1. The scheme has been designed in partnership with the Hullbridge Parish Council.

# 6 **RESOURCE IMPLICATIONS**

- 6.1. Once the brief is handed over to Essex County Council, that authority will carry out full design and monitor the contract works.
- 6.2. At present, it is envisaged that the scheme can be met from the budget allocation of £100,000 contained within the capital programme.

# 7 RECOMMENDATION

It is proposed that the Committee RESOLVES

- 7.1. To agree the design for the Hullbridge Village improvement scheme.
- 7.2. To agree that the proposed resurfacing works to the shop frontages be carried out at the expense of the Council.
- 7.3. Subject to 7.1 and 7.2 above, to instruct Essex County Council to proceed with the design of the scheme.
