### 62 AREA COMMITTEE – INITIAL BUSINESS

#### **Apologies for Absence**

Apologies for absence were received from Cllrs Mrs R Brown, M R Carter, Mrs L M Cox, K H Hudson, P R Robinson and J Thomass.

#### Minutes

The minutes of the meeting held on 19 January 2010 were approved as a correct record and signed by the Chairman.

At this point the Committee adjourned the formal meeting to move into the Community Forum to hear contributions from members of the public.

#### 63 COMMUNITY FORUM

Note: Cllr Mrs H L A Glynn declared a personal interest in the part of this item relating to British Rail works by virtue of having experienced property flooding.

Questions raised during the Community Forum and the responses given are set out in the appendix to these Minutes.

Responding to observations on the District Council's tree planting programme the Portfolio Holder for the Environment, Cllr M G B Starke, advised that, whilst officers could be advised of a suggestion that additional planting be undertaken in the Main Road/Rectory Road area of Hawkwell, the next stage of the current Programme relates to the Hockley area.

It was noted that the Chief Executive of NHS South Essex had provided written clarification to some questions raised by Hockley Parish Council. Copies had been posted on Parish notice boards.

In reconvening the meeting the Chairman reported that British Rail was currently carrying out works to clear the railway embankment adjacent to Magnolia Road between Lincoln Road to the east and Rochford Rugby Club to the west of tree shrubs and growth. In terms of assisting surface water/land drainage, Hawkwell Parish Council had suggested to British Rail that it would be most benefitial if they also cleared the ditch at the front of the embankment whilst the tree work is being carried out. The Parish Council was asking the Area Committee to lend its support to the Parish Council in this matter.

It was noted that there would be no cost to the District Council in supporting this request, which related to British Rail land. During discussion reference was made to the poor state of the chain link fence on the White Hart Lane railway bridge.

### Resolved

That the Area Committee lends its support to Hawkwell Parish Council in this matter, the poor state of the chain link fence on the White Hart Lane railway bridge to also be raised with British Rail. (HLEMS)

## 64 SPOTLIGHT ISSUES

#### (1) Essex County Council integrated Youth Service and the Rochford District Youth Council

The Committee received presentations from Mr Hughes of the Integrated Youth Service and the representatives from the Rochford District Youth Council.

Mr Hughes advised that the County Youth Service had merged with Connexions in September 2008 to become the Integrated Youth Service. There were currently personal advisers in every educational establishment, providing a range of support to youngsters on issues relating to GCSE options, future employment, post-16 and further education.

Targeted personal advisers worked with young people with multiple needs or barriers to education or employment. The Connexions team provides a range of activities for young people and works closely with the youth team, helping with informal learning around developing young people's confidence and self esteem. The team engages in various programmes, such as complementary education, supporting young people having difficulties with the mainstream curriculum in schools and helping to re-engage them in the learning process.

The Youth Service also delivers a Youth Action Agenda. The Area's Youth Bank Team receives funding from the Government to award to local young people who want things to do or places to go. The Youth Bank receives funding applications and identifies successful bids and allocates awards. The Team holds regular presentation events, facilitated and hosted by young people themselves. There are Youth Councils in every District and Borough across Essex.

The Rochford District Youth Council began about five years ago. The Youth Council held an inaugural Rochford Youth Conference, which allowed members to discover the main areas affecting the District and what were the most important topics for young people in the area. Representatives from the District Council, Connexions and a number of other youth services were invited to the day-long conference. The conference resulted in yet more new members and three working groups were established looking at health, publicity and the environment.

The Youth Council is seeking to create a better understanding of the other groups in the area with which it can link in order to improve its work and the ways in which it can publicise its work.

In responding to questions, the Youth Council Representatives advised that:-

- The perception of young people is that Rochford District has a low crime rate. This is borne out by the work of the Youth Council's Crime Sub-Group. Issues such as health and the environment are seen as of higher priority.
- Research had established that only 15% of young people are aware of facilities that are available to them, which points to the value of publicity. It was likely that many young people would use outdoor gym facilities. Youth cafes can also be a good idea.

On behalf of the Committee, the Chairman thanked and congratulated the Youth Council representatives for their presentation and work. The District Council's Portfolio Holder for Young Persons, Adult Services, Community Care and Wellbeing, Health and Community Safety, Cllr Mrs L A Butcher, advised that she would welcome being able to seek the views of the Youth Council on the subject of public safety.

# (2) Update on Crime and Disorder in Hawkwell, Hockley and Hullbridge

Sergeant Schwarz provided a verbal update on crime and disorder in Hawkwell, Hockley and Hullbridge. Rochford was a safe District and the Police were committed to reducing and allaying fears. Anti-social behaviour and other crime was reducing. The Police endeavoured to meet repeat victims of anti-social behaviour within sixty minutes.

Responding to questions, Sergeant Schwarz confirmed that a selection process was in place to fill a recently vacant post. It would be appropriate for Hockley Parish Council to correspond with Chief Inspector Graham Westley on suggestions for an accommodation facility that could be used by the Police. In terms of office arrangements the Police had to be mindful of ICT, supervisory and other issues. The observation that use of the term 'robbery' within statistics could give a misleading impression when it includes items such as bag snatching would be reported back.

The Chairman thanked Sergeant Schwarz for his contribution.

## 65 CENTRAL AREA UPDATE

The Committee received the Central Area update.

## Items 1/10, 2/10 and 3/10 relating to NHS South Essex

It was felt that the progress information provided by NHS South Essex in response to these issues was not sufficiently definitive. In terms of comparisons between service provision in Southend Borough and Rochford District it would be of value to have specifics on expenditure and related dates. It would also be useful to know when an annual update report card would be available.

## Bench Seat in the Clements Hall Grounds (Item 4/10)

It was noted that a location had been agreed for the bench seat.

## Speeding Traffic in White Hart Lane from the public open space to the Royal British Legion (Item H 14/09)

On behalf of Hockley Parish Council, Cllr B Hazlewood extended thanks to County Highways for the various facilities being provided to help address local issues.

Pat James, Hawkwell Hawkwell Park Drive, rear of print shop (possibly now empty) and fronting Main Road but rear of property lies in Hawkwell Park drive. Pat James, Hawkwell Parking on Hawkwell Park Drive at the junction of Main Road – vehicles park at this end of Hawkwell Park Drive, making it very difficult to see approaching vehicles coming into HPD from main Road. The vehicle trying to leave cannot see when behind a parked car when a vehicle is likely to come into the road as they tend to enter fast due to approaching traffic coming down the hill from Hockley and swing into HPD at speed. Pat James, Hawkwell Grass verges Rectory Road from Clements Hall Way to Windsor Gardens. Some grass verges are a disgrace due to illegal car parking on them. This has made the grass verges full of vehicle tyre ruts, the grass very muddy or none existent and the vehicles through constant use have made the footpaths muddy too. This has become worse in latter years as residents that respected the area have moved and new residents moved in. They need a reminder that the grass verges are not to be used for parking cars. One way to prevent this from being a constant car parking facility would be for the Council to plant trees of an ornamental variety, flowering cherries, mountain ash etc. Please do not ask the residents beforehand (as HPC did before) whether they would like a tree as this gives them the option to say no and to continue to use the verges for cars but to make the grass verges inaccessible to cars. This has been carried out at the other end of Rectory Road on the grass verges and along Ashingdon Road, is this something Hawkwell West can adopt too? I am pleased that the new crossing has been started on Main Road but I am disappointed that it has not been located in the requested area for children walking to school between Thorpe Road and Tudor Way. Instead it has been located south of Thorpe Road which would require school users walking further. This distance may only be an additional 20 metres or so but from the experience at Golden Cross you would have thought that Highways would have learnt a lesson?	This matter will be raised with County Highways who will be asked to consult with the local Ward Members/residents as appropriate.
